

ENVIRONMENTAL LABELING INFORMATION - IMERYS Laufenburg GmbH

On 11 September 2020, the legislative decree 3 September 2020, n. 116, which transposes EU directive 2018/851 on waste, and EU directive 2018/852 on packaging and packaging waste, was published.

In particular, the art. 3 paragraph 3, letter c) of the decree has made changes to paragraph 5 of art. 219 of the legislative decree 3 April 2006, n. 152 (and subsequent updates and amendments), "Environmental regulations", on the subject of "Informative criteria for the management of packaging waste", which implements and now reinforces the provisions of art. 8 paragraph 2 of Directive 94/62/EC.

It is envisaged that all packaging "be suitably labeled in the manner established by the applicable UNI technical standards and in compliance with the decisions adopted by the Commission of the European Union, to facilitate the collection, re-use, recovery and recycling of packaging, as well as to give correct information to consumers on the final destinations of the packaging. Producers are also obliged to indicate, for the purposes of identification and classification of the packaging, the nature of the materials used, on the basis of Decision 97/129/EC of the Commission".

As regards the B2B circuit, packaging intended for commercial and/or industrial use, the coding of the composition materials must be reported in accordance with Decision 129/97/EC.



As an alternative to physically labeling the packaging, the necessary information may be available via digital channels (ex. APP, QR code, web page...) or via transport documents or other documentation accompanying the goods.


The use of digital is always allowed and digital channels can completely replace or integrate the information shown directly on the packaging.

These tools can be used to facilitate the transmission of mandatory information along the supply chain in commercial and industrial circuits.

Alternatively, these instructions can be disseminated and made accessible through traditional and digital communication channels, through campaigns and/or initiatives promoted directly by the companies.

Attached to this document, you will find documentation relating to the environmental label developed by Imerys Laufenburg GmbH to fulfill the legislative requirement of the Decree 152/06 and subsequent amendments.
